2. The last date and time for uploading of e-tenders is 20.10.2018 till 3:00 pm. Tender(s) received after the due date and time shall not be considered.
3. Each tender must be accompanied with earnest money deposit of Rs.95000/- (Rs. Ninety Five Thousand only) acceptable in the Physical form of Account payee Demand Draft/Banker's Cheque/FDR from any of the commercial banks, payable at Chandigarh, drawn in the name of The Librarian, T.S. Central State Library, Sector 17, Chandigarh on or before 20.10.2018 till 3:00 pm., failing which tender shall not be entertained and shall be rejected. Earnest money in any other form is not acceptable and the tender shall be treated as invalid.
4. Tender(s) received without Earnest Money Deposit or not in the form specified in the Tender Document will not be entertained and shall be rejected straightway.
5. The successful tenderer to whom the contract for the supply of RFID Equipment/System items is awarded, shall have to furnish Performance Security of Rs. 95,000/- (Ninety Five Thousand Only) in the shape of Demand Draft or Bank guarantee or FDR duly pledged in favour of The Librarian, T.S. Central State Library, Sector 17, Chandigarh.
6. This tender form is not transferable.
7. The Technical bid of e-tender shall be opened on 22.10.2018 at 11:00 am in the office of the Librarian, T.S. Central State Library, Sector 17, Chandigarh. In the event of the date of receipt or opening of tender being a holiday or being declared a holiday, the last date of receipt/opening of the Tender shall be the next working day at the same time and venue.
8. Financial bids of only those tenderer will be opened whose Technical Bids are found to be acceptable as per tender specifications as enumerated in the schedule of Technical specification/requirement.
9. In case of tie when two or more firms quote the same rates, revised sealed bids may be invited only from the L1 firms and in case there is again tie, the award of contract may be made through draw of lots. However, only 11 firms should be entertained in such cases as per GFR/CVC guidelines.
10. Conditional offer shall be rejected.
11. It is mandatory for the bidder to bid for all the items as per Annexure I ("Price Bid").
11. Supply, testing and installation of Radio Frequency Identification (RFID) system integrated with:
 - a) **Existing Library Management System (LMS) – LIBSYS 7**

12. RFID based Library System in the Library is related to: RFID Work Station; RFID Security Gates; Supply of RFID Tags and its integration with LMS and other associated items/works. Initially the library will cover 1.25 lakhs books. All the RFID components chosen for complete solution must conform to ISO 15693 / ISO18000-3 and certificate from OEM is required.
13. The Manufacturer/Dealer/Supplier will be required to supply, test, install and implement RFID based library system with LMS (Libsys 7) at a designated location in the in the Library, T.S. Central State Library, Sector 17, Chandigarh
14. The T.S. Central State Library, Sector 17, Chandigarh Library (TSCSL-17) has been using LMS “LIBSYS” (v7) for the last 14 years.

(b) above, the Bidder should check the compatibility issue for integration of “LIBSYS” database with the RFID based library system and migrate existing library data for RFID integration. Proper functioning of the system (Both LMS and RFID) shall be the sole responsibility of the Bidder.
15. The Bidder will be fully responsible for standard integration using SIP2/NCIP protocol with LMS and the performance of all components of the RFID equipment and materials being supplied and installed and any malfunction/defective materials should be replaced free of cost during the warranty period.
16. It would be responsibility of the Bidder to demonstrate functioning of entire RFID system and other equipment on LMS being used. The entire system should be compatible with the LMS.
17. The Bidder shall agree to provide local customization and personalization of the proposed RFID based library system during its implementation and warranty period to ensure flawless functioning of the RFID based library system in the T.S. Central State Library, Sector 17, Chandigarh
18. The items of the RFID based library system should be as per the specifications and of the approved quality. The items or the service which do not conform to the approved specifications will have to be replaced by the Manufacturer/Dealer /Supplier.
19. The system shall have a minimum warranty/guarantee period of one year from the date of its implementation. Any defects or deficiency in the service shall be the responsibility of the Bidder/Service Provider.
20. The time limit for successful implementation of the RFID based library system in the T.S. Central State Library, Sector 17, Chandigarh shall be four months from the date of award of contract.
21. The requirements of the Institute in terms of category of RFID Equipment/System, detailed specifications and quantity is given in Annexure C.
22. The Librarian, T.S. Central State Library, Sector 17, Chandigarh reserves the right to change the quantity for any/all items without assigning any reason.
24. Payment will be made after receipt of RFID Equipment/System its installation and integration and then its inspection by the Technical Committee/Physical Verification Committee. No advance payment or payment against proforma invoice will be made.

25. The firm/ company/partner must submit the valid ISO 15693 / ISO18000-3 certifications for all the RFID components chosen for complete solution Certification online.
26. All damaged or unapproved RFID Equipment/System items shall be returned at the risk and cost of the Tenderer and the incidental expenditure there upon shall be borne by the concerned party.
27. The quoted prices must be inclusive of Excise Duty and sales tax / VAT etc., (if applicable). Meaning thereby, the tenderer has to include excise duty, VAT and any other duty/surcharge in the price.
28. Rates should be quoted F.O.R. Librarian, T.S. Central State Library, Sector 17, Chandigarh, including packing, forwarding, postage and freight etc.
29. The Librarian reserves all rights to reject the RFID Equipment/System, if the same is not found in accordance with the required description/specifications.
30. In case of violation of any term and condition as mentioned, Earnest Money Deposit of the tenderer shall be forfeited in full or part at the entire discretion of the librarian, T.S. Central State Library, Sector 17, Chandigarh.
31. The items should have one year guarantee from the date of its implementation.
32. The tendering firms should keep their offers valid for acceptance upto 365 days. If the firms are unable to keep their offers open for the above said period, they should specifically state the period for which their offers would remain open but such a provision may result in the rejection of their offers, provided, however, that in the event that the day upto which the offer is to remain open is declared holiday for T.S. Central State Library, Sector 17, Chandigarh the offer shall remain open for the next working day.
33. The material must be delivered within 45 days from the date of issue of supply order; otherwise penalty @ 0.1% of the cost of the item/s per day for the period delayed over shall be deducted out of actual bill at the time of release of payment.
34. The bidder must submit a proof of satisfactory completion of project of minimum five Libraries at the National level /State level where RFID integration with LIBSYS (LMS) is in operation with RFID for at least three years.
35. The Bidder is expected to quote rates after careful analysis of the costs involved for the performance of the complete work as per the needs of the Institute's Library. Nothing extra shall be payable on any pretext at any stage later on.
36. Authorization letter from the Manufacturer stating that the Bidder is authorized dealer of the Manufacturer.
37. Self- Certification stating that the items which have been identified for end of sale or the items which are still under trial has not been quoted.
38. Should have local technical and service support based in tircity (Chandigarh, Panchkula and Mohali). Attach documentary proof.
39. Any conditional tender or any deviation from the terms and conditions of the tender document shall render the tender liable to rejection.
40.
